Real Time Automation REACH Statement

February 3, 2018

Real Time Automation is aware of EU Regulation (EC) no. 1907/2006 of the European Parliament and of the Council, entered into effect on June 1, 2007, concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH).

It is our understanding that the only provisions of REACH applicable to Real Time Automation products are the REACH requirements regarding articles, which apply to Real Time Automation modules and shipment packaging. The REACH requirements are:

- To inform recipients if an article placed on the European market contains a Substance of Very High Concern (SVHC) in excess of 0.1% by weight. SVHCs are listed in REACH Article 59(10) and identified on the European Chemical Agency (ECHA) website.
- To notify ECHA if an article contains an SVHC in excess of 0.1% by weight and the SVHCs in each such article placed on the European market exceed one metric ton per year.
- To cease shipment of articles containing restricted substance specified in REACH Annex XVII.
- Our products do not contain the substances within the 181 entries currently on the SVHC Candidate List in excess of 0.1% by weight per article as published by ECHA with latest publication date 15-Jan-2018.

Based on the information available to us from our raw materials suppliers, to the best of Real Time Automation's knowledge and belief, all of our modules comply with the REACH Directive as it relates to the SVHC. The SVHC will be updated in the future by the ECHA. At that time, Real Time Automation will issue another certification that will reflect the updated SVHC. This document is valid without signature and replaces all former statements made by Real Time Automation concerning REACH and the SVHC.
